Reserve Fund for Payment of Bonded Indebtedness

GML Section 6-h

Grant Road Bridge

RESOLVED, that pursuant to Section6-h of the General Municipal Law, as amended, there is hereby established a Reserve for Bonded Indebtedness (Debt Reserve Grant Road Bridge) fund to be known as "Grant Road Bridge Debt Reserve" (hereinafter as Debt Reserve Fund). The purpose of this Reserve Fund is to account for funds that were received from FEMA in 2023, well after the completion of Grant Road Bridge in 2013. The debt for the Grant Road Bridge is part of the attached amortization schedule. There is (10) years remaining on the debt for the Grant Road Bridge.

The chief fiscal officer is directed to deposit and secure the moneys of this Reserve Fund in the manner provided by Section 10 of the General Municipal Law. The Town Board and or the Chief Fiscal Officer may invest the monies in the Debt Reserve Fund in the manner provided by Section 11 of the General Municipal Law, and consistent with the Investment Policy of the Town. Any interest earned or capital gains realized on the monies so deposited or invested shall accrue to and become part of the Debt Reserve Fund. The Town Supervisor shall account for the Debt Reserve Fund in a manner which maintains the separate identity of the Debt Reserve Fund and shows the date and amount of each sum paid into the separate identity of the Debt Reserve Fund, interest earned by the Fund, capital gains or losses resulting from the sale of investments of the fund, showing cash balance and a schedule of investments, and shall, at the end of each Fiscal year, render to the Town Board a detailed report of the operation and condition of the Debt Reserve Fund.

Except as otherwise provided by law, expenditures from this Debt Reserve Fund shall be made only for the purpose for which the Fund is established. No expenditure shall be made from this Debt Reserve Fund

without the approval of the Town Board and such additional actions or proceedings as may be required by Section 6-c of the General Municipal Law or any other law.
