# Resolution Supporting Local Law No. 1 of 2020

WHEREAS	The Town Board of the Town of Kirkland is sworn to protect the constitutional, statutory and legal rights as well as the health, safety and general welfare of the residents of the Town of Kirkland; and
WHEREAS:	The rapidly growing solar energy industry is in the process of selecting sites for solar energy systems ("SES") in municipalities throughout our region; and
WHEREAS:	The Town Planning Board of the Town of Kirkland is aware that at least one solar energy company is interested in possibly siting a SES in the Town; and
WHEREAS:	As of this date there are no applications submitted to the Town proposing to place SES in the Town; and
WHEREAS:	Section 118.49 of Article VI, entitled "Solar Energy Systems," was adopted on the 25 <sup>th</sup> day of April, 1996; and
WHEREAS:	The Zoning Ordinance of the Code of the Town of Kirkland does not adequately address SES, the Planning Board believes that a uniform regulatory scheme for the construction and operation of SES and neutral procedural controls for the rigorous review of land use petitions should be devised; and
WHEREAS:	The intention of the amendment of the Zoning Ordinance is to address all SES uses, i.e., private, commercial and industrial; and
WHEREAS:	The Town Board and the Planning Board believe that a proposed moratoria is a valid land use control which will allow the Planning Board to conduct a formal review of the issues involved in SES, review proposed regulations, and make appropriate recommendations to the Town Board; and
WHEREAS:	The moratorium will not prohibit or unreasonably inhibit fair competition as all applicants and applications will be treated equally under the moratorium; and
WHEREAS:	The moratorium does not regulate entry into the solar energy market; and

WHEREAS: The Town Board and Planning Board will begin drafting language for the amendment to the Zoning Ordinance for Town Board review and approval; and

WHEREAS: Models and samples of other municipalities' recent amendments relating to SES have been gathered and it is anticipated that preparation of the regulations for final action by the Town Board may require several months to one (1)calendar year, i.e., twelve (12) calendar months.

NOW, THEREFORE, BE IT RESOLVED, that the Planning Board respectfully requests the Town Board to enact a moratorium on the submission and/or acceptance of applications, construction, erection and/or installation of SES in the Town of Kirkland for a period of six (6) calendar months. This will allow the Planning Board and the Town Board to actively study and legislate during this period.
