Resolution: Establishment of

Capital Reserve (Facilities) Fund

RESOLVED, that pursuant to Section6-c of the General Municipal Law, as amended, there is hereby established a capital reserve fund to be known as the "Building Facilities Reserve". The purpose of this Reserve Fund is to accumulate moneys to finance the cost of Building Improvements to the Police Building, the Town Offices and the Seniors Building. The type of improvements to be financed from the Reserve Fund are for Interior or Exterior Improvements.

The chief fiscal officer is directed to deposit and secure the moneys of this Reserve Fund in the manner provided by Section 10 of the General Municipal Law. The Town Board and or the Chief Fiscal Officer may invest the monies in the Capital Reserve Fund in the manner provided by Section 11 of the General Municipal Law, and consistent with the Investment Policy of the Town. Any interest earned or capital gains realized on the monies so deposited or invested shall accrue to and become part of the Capital Reserve Fund. The Town Supervisor shall account for the Capital Reserve Fund in a manner which maintains the separate identity of the Capital Reserve Fund and shows the date and amount of each sum paid into the separate identity of the Capital Reserve Fund, interest earned by the Fund, capital gains or losses resulting from the sale of investments of the fund, showing cash balance and a schedule of investments, and shall, at the end of each Fiscal year, render to the Town Board a detailed report of the operation and condition of the Capital Reserve Fund.

Except as otherwise provided by law, expenditures from this Capital Reserve Fund shall be made only for the purpose for which the Capital Reserve Fund is established. No expenditure shall be made from this Capital Reserve Fund without the approval of the Town Board and such additional actions or proceedings as may be required by Section 6-c of the General Municipal Law or any other law.
