A letter was received from Councilman Cook from the Town of Huntington, NY, he asked that our Board sign a resolution urging the NYS Legislature and Governor to draft and enact legislation regarding a voter identification process. This letter has been sent to Town Attorney Hallak for his review and advisement.

Councilwoman O'Neil presented proposals for the 2023/24 ice season, being:

^{*}The hourly rate increased to \$140 from \$135 per hour.

^{*}Propose an increase to Clinton Central School to \$26,000

^{*}Clinton Youth Hockey & Clinton Figure Skating Club are contracted for every hour of prime time they must take two hours of off prime. It is proposed this is changed and charge \$100 per hour for both organizations and not average out prime and off prime.

^{*}Public Skating will stay the same \$5 admission and \$5 skate rental.

The rates have not been raised since COVID and are still less expensive than other arenas. Board Members were all in agreement and changes will go into effect.

The DRI committee will hold a public meeting on June 5th from 1-3 pm in the Board Meeting Room in the Town Hall.
