In the event of your neglect or refusal to comply with this order to secure and demolish the building, the Town Board is authorized to provide for demolition and removal of the structure. All expenses of demolition are subject to being assessed upon the land on which the structure is located. The Town may also maintain a special proceeding against you to collect the costs of demolition, including legal expenses.

Capital Reserve (Type) Fund

RESOLVED, that pursuant to Section6-c of the General Municipal Law, as amended, there is hereby established a capital reserve fund to be known as "Arena Equipment Reserve Fund" (hereinafter Zamboni Reserve Fund"). The purpose of this Reserve Fund is to accumulate moneys to finance the cost of a Zamboni. The type of equipment to be financed from the Reserve Fund is the purchase of a Zamboni.

The chief fiscal officer is directed to deposit and secure the moneys of this Reserve Fund in the manner provided by Section 10 of the General Municipal Law. The Town Board and or the Chief Fiscal Officer may invest the monies in the Capital Reserve Fund in the manner provided by Section 11 of the General Municipal Law, and consistent with the Investment Policy of the Town. Any interest earned or capital gains realized on the monies so deposited or invested shall accrue to and become part of the Capital Reserve Fund. The Town

Supervisor shall account for the Capital Reserve Fund in a manner which maintains the separate identity of the Capital Reserve Fund and shows the date and amount of each sum paid into the separate identity of the Capital Reserve Fund, interest earned by the Fund, capital gains or losses resulting from the sale of investments of the fund, showing cash balance and a schedule of investments, and shall, at the end of each Fiscal year, render to the Town Board a detailed report of the operation and condition of the Capital Reserve Fund.

Except as otherwise provided by law, expenditures from this Capital Reserve Fund shall be made only for the purpose for which the Capital Reserve Fund is established. No expenditure shall be made from this Capital Reserve Fund without the approval of the Town Board and such additional actions or proceedings as may be required by Section 6-c of the General Municipal Law or any other law.

Dear Supervisor Meelan:

I regret to inform you that your application for the **Edward W. Stanley Recreation Center Improvement Project** submitted for the Environmental Protection Fund Grant Program for Parks, Preservation and Heritage (EPF) has not been selected for funding.

For this year's competition, we received 255 eligible applications through the Consolidated Funding Application (CFA) requesting over \$90.4 million. With only \$19.5 million available for distribution, not all eligible projects could be funded.

This does not pertain to potential funding awards from other agencies or programs and does not preclude you from applying for future CFA funding rounds.
